



AGREEMENT

for the supply of M2M/IoT mobile communications services

This agreement is made on the 16/02/2023 ("Effective Date") by and between **1NCE GmbH**, Sternengasse 14-16, 50676 Cologne, Germany (hereinafter "1NCE") and **R.E.M. S.R.L.**, Via Ferruccia 16/A, 03010 Patrica (FR), Italy (hereinafter "Customer"). 1NCE and the Customer are hereinafter collectively referred to as the "Parties" and individually as the "Party".

WHEREAS:

- 1NCE provides mobile communications services for machine-to-machine ("M2M") and Internet of Things ("IoT") applications and related services to enterprise customers.
- The Customer is an Enterprise Customer and carries out industrial activities in the field of the IoT.

NOW THEREFORE, THE PARTIES DO HEREBY MUTUALLY AGREE AS FOLLOWS:

1 SUBJECT OF THE AGREEMENT

The subject of this agreement is the provision of mobile communications services for machine-to-machine ("M2M") and Internet of Things ("IoT") applications and related services by 1NCE (collectively the "Services") as set forth in this agreement, and the latest version of the [General Terms and Conditions of 1NCE GmbH for M2M/IoT mobile communications services](#) ("GTC")¹ and the [Service Description](#) ("Service Description") applicable at the time of each order (hereinafter "Agreement").

2 TARIFF(S)

2.1 The Parties agree on the following bespoke Tariff(s):

2.2 The stipulated price in Section 2.1 is in Euro net. The Customer intends to purchase a total number of 15 IoT SIMs of Tariff 1112 by 31/12/2023 at the latest.

2.3 The Lifetime of the respective IoT SIM begins three months after the day on which 1NCE dispatches the IoT SIM to the Customer. The initial activation of the IoT SIM takes place before the IoT SIM is sent out to the Customer; the IoT SIM, in particular the data and SMS volume ordered, can therefore be used from the moment of receipt by the Customer.

3 PAYMENT TERMS

3.1 Section 5.2 of the GTC shall be applicable.

4 TERM AND TERMINATION

4.1 This Agreement shall come into force at the Effective Date and remains in force for an indefinite period unless terminated by either Party by giving the other Party a six (6) months' notice period.

4.2 The termination of this Agreement shall not affect any order the Customer has previously placed which is based on the conditions set forth in this Agreement. Obligations concerning outstanding orders and/or invoices will survive the termination of this Agreement. Any terms and conditions of this Agreement which by nature are intended to survive termination shall continue indefinitely.

5 CONFIDENTIALITY

Section 10 of the GTC shall apply accordingly to this Agreement.



6 GOVERNING LAW AND JURISDICTION

Sections 13.4 and 13.5 of the GTC shall apply accordingly to this Agreement.

7 HIERARCHY OF DOCUMENTS

- 7.1 Unless explicitly otherwise agreed in this Agreement, the provisions of the GTC and the Service Description shall apply in all other respects.
- 7.2 In the event of any conflict between the terms of this Agreement, the GTC and the Service Description, the order of precedence is as follows: (i) the terms of this Agreement and (ii) the GTC and the Service Description.

8 FINAL PROVISIONS

- 8.1 The Parties agree that this Agreement, amendments thereto or other documents referring to this Agreement may be signed only in writing or by using electronic signatures. A qualified signature in accordance with Regulation (EU) No. 910/2014 is not required. This requirement may in turn be waived only either by written agreement or an agreement with an electronic signature.
- 8.2 This Agreement contains the entire agreement between the Parties with respect to the subject matter hereof; no side agreements have been entered into. This Agreement supersedes all prior agreements and understandings with respect to its subject matter.
- 8.3 Except as expressly set forth in this Agreement or permitted under mandatory law, the Customer may not assign, delegate, or otherwise transfer any of its rights or obligations under this Agreement without the prior consent of 1NCE. 1NCE may, without the consent of the Customer, assign the rights and obligations under this Agreement or any order which is based on it, in whole or in part to its affiliate companies.
- 8.4 Should any provision of this Agreement, or any provision incorporated into this Agreement in the future, be or become invalid or unenforceable, the validity or enforceability of the other provisions of this Agreement shall not be affected thereby. The same shall apply if the Parties have failed to address a certain matter in this Agreement. The invalid or unenforceable provision shall be deemed to be substituted by, and the Parties shall be deemed to have agreed upon, a suitable and equitable provision which, to the extent legally permissible, comes closest to the purpose of the invalid or enforceable provision or to the presumed intent of the Parties had they considered the matter.





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, 1NCE GmbH (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

To withdraw your consent with 1NCE GmbH

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- ii. send us an email to lea.schreiber@1nce.com and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
