# **Description of lending service**

- Dispositions of equipments and control and measure equipments need for taken care of maintenance /installation.
- Demonstration of good elimination of breakdown and restoration of normal condition of operation.

# Engagements of the Customer

- To supply all the information on the existing specific risks in operative area in which the specialist staff it will carry out the own activity and on the prevention measures and emergency adopted. Therefore, in case of missing communications, the operative location will be considered, under the exclusive responsibility of the customer, lacking risks; the personal, stating the existence of specific risks or stating the absence of prevention measures or emergency, it will be able to be abstained to carry out the previewed activity.
- To put in action all the necessary measures of prevention of the accidents and of hygiene of the job previewed in the enforced norms to realize eventual conditions of essential service to execute an activity.
- To supply all the generical equipments that it will became necessary to the development of the job and to guarantee, if demanded, the presence of own support staff.

#### Modality of Demand and Execution time of Technical Interventions

- The technical interventions will be effected in the smaller possible time and will starting from the reception of a fax with the Customer confirmation of the present tariff(price & condition)or of the dedicated repairing offer.

#### Terms e Modality of Payment

- The present tariff list it's valid for all effected performances from technical personal on Italian territory.
- The employed transport it's chosen by our judgment, only in case of various indication from Committee, the beginning from the main place(Bra) will be effected in different
- timetables from **normal**; the travel comes calculated with beginning from our centre of Bra -CN-
- The intervention cost it will be agreed in preventive offer phase.

# Repairing costs and Equipments not in guarantee

- The cost of the repair or substitution is in function of the type of breakdown endured from the component and it will supplier, when it's possible, on demand before the participation of technical attendance.
- The cost of the repair or substitution will be debited <u>however</u>, extended also at the components on guarantee(Garanzia Materiali), where was needed for breakdown not imputable at itself breakdown component, negligence, not correct use or inobservance of our institutions.
- The Guarantee granted on the replaced materials during for 6 months from the date of substitution only in case of various indication.

#### **Responsibility and Controversies**

Fimet Motori e Riduttori S.p.A. doesn't assume other responsibility or obligation beyond these was request from present tariff. Explicitly are excluded the responsibility for direct/indirect damages of every type, for person or for material of client property.
